Rajaa Berezag, Anthony and Marie O'Reilly and Paul Donley courageously shared testimony in how they/their family were impacted by terrorism related events.


The event was extremely powerful with a large number of MLA's, academics, clergy and other policy makers joining victims/ survivors.

## The Tribute to Innocents Memorial Quilt Exhibition

The Exhibition was launched on Tuesday 6th March 2018 in The Long Gallery, Parliament Buildings. Stormont to over 200 attendees.

12 Memorial Quilts were displayed remembering almost 900 individual innocents murdered over the course of 'The Troubles' by republican and loyalist terrorists.

The key messages of the Memorial Quilts are:

- 1. Violence was futile and totally unjustified.
- Those remembered were wholly innocent.
   The legacy of those represented will live on amongst those left behind.

Ordinary men, women and children from right across the community were treated as collateral damage during 'the Troubles,' and this continued within the concessions granted terrorism and its' political annexes within The Belfast Agreement, and subsequent agreements (both overt and covert) This continues to exist to this day due to the justice, truth and accountability deficit being borne by innocent victims/survivors of terrorism. The rest of Society once again expects victims and survivors to assume the role of collateral damage and to accede to the drive for political amnesty to be granted for pre 1998 terrorist and other criminal-based offences committed over the period referred as; 'The Troubles.'

SEFF's Memorial Quilts are now on their travels again and will be displayed in Liverpool University for the next month for a prestigious exhibition marking 20 years since The Belfast Agreement.

The message of the Memorial Quilts within the exhibition is profound - the unfinished business of victims and legacy related issues.















### We welcome reports of victim papers but still have concerns about legacy structures - IVU

In recent days there has been fresh speculation that a paper was passed over the duration of recent talks between the DUP and the provisional movement. We give a cautious welcome to the statement made by the DUP leader, Arlene Foster. She stated that a paper had been exchanged with Sinn Fein on the "treatment of innocent victims".

The proposed parameters of the Historical Investigations Unit (HIU) and Independent Commission on Information Retrieval (ICIR) will not deliver anything tangible for the overwhelming majority of innocent victims of terrorism.

We have asked for a commitment that in meeting the fundamentals of equality that all cases, irrespective of whether or not they'd previously been reviewed by Historical Enquiries Team (HET) would have an investigation. We also continue to ask that government examines housing the coronial inquest system within the new HIU structure. The legal advices we have obtained states that this is possible so why does it remain external from the new HIU structure?

In short it is better to develop no further legacy structures (HIU, ICIR or Implementation and Reconciliation Group - IRG) unless there is a means to deliver for the innocent.

Crucially we have lobbied for a statement of wrongs to be signed up to by the proscribed terrorist organisations, UK and Republic of Ireland states. If achieved, then this would act as the foundation stone for further sustainable progress to occur.

We are however unclear as to the content and obviously we are aware that no formalised agreement was made on such proposals by the DUP, the provisional movement and the UK government.

Innocent Victims United (IVU) has campaigned vociferously since the development phase of Eames-Bradley, pointing out the justice deficit experienced by innocent victims/survivors of terrorism and calling for legacy processes which will genuinely hold terrorism accountable.

We have campaigned for public debate around the need for change to the government's definition of victim which has caused and continues to cause huge distress to the innocent. We have campaigned for resolution to the former Libyan regime's sponsoring of PIRA terrorism, the stand-off on pensions for innocents who were seriously injured and we have also urged for more robust legislation concerning the glorification of terrorism and a will to prosecute once breaches are made.

And we have implored the government to fully implement the mental trauma based service previously committed to she which has saw little meaningful progress.

If these issues were within those papers then we welcome efforts made to advance them and if they weren't then we ask, why not?

#### Equality of access to justice pathways essential - IVU

Kenny Donaldson, Spokesman for Innocent Victims United stated: "Following the collapse of the recent political talks process Gerry Kelly of SF/PIRA claimed that the Provisional Movement had received a commitment from the UK Government that they would release monies for legacy inquests and that the NIO legacy consultation would not include statute of limitation for security force members. The UK Government has confirmed that these commitments were pending an overall agreement being reached between The Provisional Movement and the DUP".

"We have consistently stated our opposition to Statute of Limitations on the grounds that we do not believe the military (particularly Home Service) wish in any way to be equated with terrorists. We are clear as are those tens of thousands who served within the security forces with honour and integrity that where there were breaches of the code and criminal-based activities committed by individual members of the security forces that they should be held accountable".

"We certainly won't be holding any store in the words of a convicted terrorist and who was responsible for being the lead conduit for his 'Army's' statute of limitation, otherwise known as OTR Assurance letters. These letters must be legally rescinded by the UK Government or there is very real prospect for an abuse of process argument to be successfully mounted in a future case concerning a recipient of an OTR letter".

"As an organisation we are also clear that we support all innocents from across the community who pursue justice, truth and accountability but we are clear there must exist equitable pathways with equitable levels of resource which means that all can advance their objectives".

## FACT FEBRUARY 2018 UPDATE

As I write this the clock will soon be going forward an hour and we will soon see longer days and shorter nights which will encourage us all to get out and about after such a long

winter.

We recently held a consultation event in Corick House Hotel, the purpose of this was to tease out new ideas for future funding. The event was well attended by Fermanagh and Armagh members, this helped the consultant to put together information to use for future funding applications which we are hopeful it may be possible to keep the FACT Project in operation past 2019. Feedback from the event touched on many issues but in particular the need to assist the membership when considering the cut backs in our pubic finances.

We are in the midst of completing and posting out the FACT Newsletter, it is packed with lots of variety and familiar classes like wood turning, up cycling, flower arranging and chair exercises to name but a few.

There is a selection of walks taking place across the two counties along with swimming lessons being introduced. We are also very happy to announce a new deal that you can partake in the Armagh City Hotel and the Killyhelvin Hotel for their health clubs.
