### Enniskillen Poppy Day Bomb Families set the record straight

The act of premeditated murder committed by the Provisional IRA in Enniskillen on 8<sup>th</sup> November 1987 (known as The Poppy Day Bomb) continues to affect every aspect of our lives some 31 years later. No-one has ever been convicted of the attack and we continue to strive for truth, justice and acknowledgement.

The South East Fermanagh Foundation (SEFF) have been representing us and working with the authorities over the last number of years, in an effort to move things forward. We have had many meetings with the police and others and are steadily building our strategy.

The frustrating issue for us is that the PSNI and the Legacy Branch appear to be more driven to pursue prosecutions against retired members of the Security Forces whilst those responsible for 90% of deaths during the Troubles are largely ignored. We want to be treated fairly; we demand Equality of focus, Equality of resource and Equality of respect. Whilst the authorities continue to ignore our case and the many others involving innocent victims, they are creating a vacuum that is allowing others with dubious motives to exploit those cases.

We recently became aware that there was an application for a new inquest into The Enniskillen Poppy Day Bombing case. To find out about this development in the local newspaper has only added to our dismay. We along with our advocate, Ken Funston of SEFF were totally unaware of this application.

The failure of this submission was exposed in the Fermanagh publication - The Impartial Reporter as an 'Exclusive', it was indeed an exclusive to the newspaper as we knew nothing about it. We understand there was one member of one bereaved family involved in the application, whilst we were all deliberately kept in the 'dark'.

What has caused us equal concern is that Denzil McDaniel, the ex-editor of the Impartial Reporter wrote in that newspaper on January 10<sup>th</sup>.

"... we cannot easily rule out the dreadful thought agents of the British State know what was going to happen and let it go ahead. In all honesty, in my opinion that is not only possible but, indeed likely."

Mr McDaniel has a right to comment as he chooses however we do not support his view, and after a recent meeting in SEFF, we wish to put on the record that this statement by Mr McDaniel is unhelpful, and deflects the blame from the

perpetrators of the mass murder of innocents by the Provisional IRA. We do not know what he has based his opinion on, but it has quite simply caused us further upset.

We are a group of families who have remain dignified down the years, perhaps to our detriment, we have watched other cases receive prominence, endless resources and focus.

We have largely held our tongues throughout the last three decades, we have heard others try to suggest that our families received high levels of compensation, we did not and many families received nothing.

We had a Memorial Garden promised to us taken away by those who thought they knew better than us, who planted a building on the site of our loved one's slaughter and then named it (The Clinton Centre) after someone deeply objectionable to many of us, we had our loved one's names added to a Cenotaph (designed to remember War Dead) and which by its' nature did not tell the truth of the a nature of our loved ones ' deaths - they were not killed, they were murdered by terrorists.

In more recent times we have not yet had our wishes reflected through the placement of the highly publicised new Memorial at the site of where our loved ones were murdered.

Surely anyone with even an ounce of Christian or human compassion would consider us as key stakeholders in whatever happens on the site of the slaughter of our loved ones, regardless of the legal status.

If the great and the good truly care for us then they would highlight these issues and they would seek reparation on our behalf and more so they would put their shoulder to the wheel in

insisting that those responsible for the bomb which committed mass murder would be held accountable for it. Is this their interest or are they merely driven by their own self-promotion?

## UNIVERSAL CREDIT ROLLOUT DELAYED FOR EXISTING CLAIMANTS IN NI UNTIL 2020

We are aware that a vast number of SEFF members who are in receipt of DLA (Disability

Living Allowance) are still awaiting the transition to PIP (Personal Independence Payment).

Our Welfare and Appeals Officers are available to meet with members and provide guidance around the various steps of the process and to ensure you have the information you need going forward. Please contact us before you start the process as not doing so could mean an adverse effect on your claim.

## Universal Credit

Plans to move existing benefits claimants from the old system to universal credit have been postponed in N.I for at least six months.

Stormont officials have confirmed that reforms that were due to begin in July have now been deferred until next year.

#### SEFF take message to Queens University, Belfast

SEFF recently facilitated a seminar at The Students Union, Queens University Belfast. The meeting was organised by The Conservative Association Queens University Branch.

We were greatly encouraged by the strong attendance numbers at the event.

SEFF provided a detailed overview of the group's work, our ethos and our vision for the Future - we left that message with the students that they along with others of their generation have a key stake and role in ensuring that the integrity of the Past is protected and that a commitment is made to genuine reconciliation something which can only be brought about through the processes of justice and truth (accountability) being fully worked through and delivered.



We were humbled and blessed that two innocent victims felt able to share their testimony; Shane Laverty (whose brother Robert was murdered as an 18 year-old RUC Officer) - this was the first occasion that Shane had spoken publicly on his brother's murder for 47 years.

And Aileen Quinton (whose mother Alberta was one of 11, to later become 12 murdered as a result of the Poppy Day Bomb).

Both acts were carried out with premeditated intent by Provisional IRA terrorists.

A very interactive Q & A session followed with engagement between SEFF representatives and those in attendance.

In a week's time a group of students from Queens University will be visiting SEFF to better understand the area from which we operate and also to experience a Border Trail which respectfully acknowledges the atrocities and events which have taken place across the Fermanagh borderlands.

We look forward to a continued good working relationships in the times ahead with students at the University.

That call won't make everything better but it can make a difference to how you are feeling, and that you are not on your own. We at SEFF care about you, and how you are feeling and give you a chance to articulate those feelings, and to acknowledge that if you are feeling isolated, lonely or down that on a weekly basis there is someone to talk to. #### European Day of Remembrance for Victims of Terrorism 2019 & visit to Bayardo Tribute to Innocents







The 2019 European Day of Remembrance for Victims of Terrorism event will take place in The Senate Chamber in Parliament Buildings, Stormont on **Monday 11th March 2019** (this is the actual date marked across Europe).

As per previous years three speakers will contribute testimony at the event, these speakers will involve innocent victims of both a loyalist and republican terrorism.

Once again SEFF are working in partnership with Jim Allister's office in organising the speakers and arrangements for the day The event is co-sponsored and supported by other political parties.

#### **Bayardo Somme Association Tribute**

The Bayardo Pub located on the Shankill road was bombed by Provisional IRA terrorists in 1975 murdering 5 people. 15 years ago the local and independent Somme group erected a memorial stone to those innocent people.

Since then the group has been building a Living Memorial on the site of the Pub containing photographs, montages and other information including as many innocents of The Troubles as possible, especially but not exclusively child victims.

Up to now the group have spent £30,000 without grants or funding from any group or body just "Work, dedication and good friends".

The group's motivation is to practically challenge the rewrite campaign of Republicanism influencing local, national and international opinion.

After the event at Stormont we plan to travel over to the Shankill Road to view the tribute before the return journey back to SEFF.

A bus will leave SEFF offices at 8am on Monday 11th March 2019, you will have an opportunity to purchase Lunch in Stormont, as mentioned we will then travel to the Shankill Road before our return journey. The bus is free and pick-ups and drop-offs can be accommodated as required.
