I want to reassure West Tyrone Gateway service members that contingency plans have been put in place to ensure that there will be other staff in place to cover the Newtownstewart office over the period of recruitment.

Over the last few months SEFF has been extremely busy and remains the group which fights for and delivers upon policy change for those issues which impact innocent victims and survivors of terrorism and other 'Troubles related violence.' We are currently involved in work which we hope will shape a Regional Trauma Network for Northern Ireland which we are determined MUST finally deliver for victims and survivors and others impacted by other forms of traumatic experience. In this regard there is currently a Public Consultation into the new RTN and we will be responding to that Consultation as a group.

Furthermore a meeting of IVU will be pulled together where the RTN Management team will come along to address groups and members. I want to thank all those who played a lead role (particularly Joy Aiken and Trevor Watson) with the recent SEFF Volunteers Acknowledgement event, this Was hugely successfully and will be an Annual event. We will continue to invest in our Volunteers who are the lifeblood of this organisation.

And good news to share; we have secured a further £33,000 which will enable us to invest in our Welfare outreach services in Newtownstewart, Omagh and Rathfriland.

SEFF Welfare & Benefits Update

#### Hi All,

As everybody is aware SEFF has three welfare officers who cover a large portion of Northern Ireland in relation to Benefits. Anything from Blue Badges to the latest addition to the Benefits Portfolio Universal Credit. Unfortunately there are often challenging changes brought about by the Dept or the Appeal Service.

The latest change which you may have heard about is that "The Appeal Service" is no longer going to apply for medical records. The Appellant now has to apply for their own records and go through, the last 4 - 6 years of records to ascertain if there is anything of value in these records. This is distressing to the appellant as it brings up memories that perhaps they wish to forget or reminds them of other issues they may



wish to forget. It also puts pressure on the Representative who also has to go through the records to make sure that there is nothing detrimental to the appellant. This eats greatly into the limited time the representatives have.

As this service is funded by the VSS it like any other body that gives out funding, it has to make sure that it is getting value for money otherwise they will remove the funding for that particular service. To this end we have to justify our existence and the only way this can be done is by spending valuable time completing more paperwork. We can only do this satisfactorily when the members we are assisting give us feedback regarding the progress and result of any application.

If you have been successful then let us know so that the result can be logged and consequently secure the continuance of the service into the future.

#### PROJECT COMMON BOND 2019 Cuilcagh Climb on Sat 15th June 2019

Six young people took part in the climb to support Kelly Beacom and Ellen Louden who will attend Project Common Bond International Peace Synopsis in Washington, USA at the end of July.

They were accompanied on the climb by Roderick Noble and Doreen Mullan, along with their guide Kevin Dockery, who has climbed it 567 times. To date the climb has raised £797, with some funds to yet come in.

Project Common Bond brings together young adults from around the world who have experienced the loss of a family member due to an act of terrorism, violent extremism, or war.

Doreen Mullan will accompany the girls and will support them along with Stefan Freeman (from Canada and whose Grandfather Cpl Stephen Smith was murdered by the Provisional IRA in Germany) and will take part in the Chaperone programme whilst there. They will continue to advocate for the work of PCB and in building a supportive arm for participants and others affected by the same trauma upon return to their community.

As above, there is a Coffee Morning & Cake Sale on **Thursday 4th July 2019 at 10.30am in SEFF Offices**, this will also be in aid of this year's Project Common Bond (PCB) trip. The coffee morning will be an Independence Day theme as it coincidentally falls on Independence Day (4th July).

## Presentation on Post Traumatic Growth & Values in Northern Ireland takes place in SEFF presented by Thea Comeau



On Tuesday 11th June 2019 we had Canadian born Thea Comeau return to SEFF. Thea had been here some four years ago to interviewed victims/ survivors of terrorism from the civilian population, the focus of her research was Posttraumatic Growth, the Research was seeking to establish and understand the linkages between exposure to trauma and altruistic acts of selflessness which those impacted then go on to complete.

Thea was given a hearty SEFF and Northern Ireland welcome and she provided a detailed presentation with slides to a packed room of members. Thea will be forwarding the full research findings to us over the coming months and her research will feature in an Academic Journal. It is her plan to return to Northern Ireland to engage with former members of security forces and their families.

## South Armagh Border Trail

South Armagh was privileged to host 47 SEFF members back on Saturday 8th June 2019 and I was privileged to be entrusted with taking the group around, explaining to them the legacy of terrorism within the area but also the very positive aspects to life in South Armagh.

South Armagh is not just a geographical location, it is a state of mind, a powerful brand and it denotes steely determination to succeed.

The day involved me first picking up the group in Armagh and travelling with them along the main Armagh-Newtownhamilton road until we were in the heart of south Armagh. The group were advised of different facts along the way and stories pertinent to the area, information was re-



layed upon the history of the Town of Newtownhamilton (which had suffered greatly over the years of 'The Troubles') We then arrived at Tullyvallen Orange Hall, the scene of a brutal sectarian-motivated atrocity which led to five innocents being murdered and many others injured (physically and mentally) next we had a stop at Mountain Lodge, Darkley where we were met by the current Pastor's wife and the organist (both of whom were present on that fateful night back in 1983) Also present within the SEFF group was Edith Howarth and her daughter (who were present on the night of the attack) along with Edith's son-in-law.

From Darkley we moved on to Crossmaglen, meandering through the narrow and narrower still South Armagh roads until we reached the Square. The group were advised of the terrible theft of lives within this area and I was able to share some of my own experiences as a child and teenager and my witness to that terrorism, We enjoyed dinner in the Cross Square Hotel and then moved on to Creggan Church of Ireland (my own wee Church which has circa 14 parishioners) SEFF members were advised of the work of the Parish and saw inside the Church and Creggan Parish Visitors Centre, the last stop of the day was at the Kingsmills Memorial where 10 innocent Protestant workmen were murdered in the most blatant case of sectarian fuelled murder of 'The Troubles.' Colin Whorton (brother of one of the victims - Kenneth Whorton) and his wife met with SEFF members and provided come comments on the families continued struggle for justice, truth and accountability.
