Dear Members,

July has been a month of welcoming new faces to the organisation.

We are delighted to advise that SEFF has been successful in its' bid to deliver an Advocacy Service for the benefit of the people of South Armagh and surrounding hinterlands.

Ian Irwin and Alan Lewis (Advocacy Support Workers) transfer across from the FRPU organisation and we are currently recruiting a further Advocacy Support Manager and a p/time Research and Admin Officer. SEFF will now open a new office in Bessbrook village to deliver the service from.

Meanwhile Esther Hurst takes over Martina Virtue's role as Health and Wellbeing Caseworker for the Western sub-Region and Clogher Valley District. We welcome all three new staff to the SEFF Family.

These last few weeks have been particularly busy and challenging for innocent victims/survivors of terrorism with the release of advices on Pensions for the seriously injured made by the Victims Commissioner. Unashamedly SEFF and upwards on 20 other organisation's have rejected her calls for those injured as a consequence of their own criminal actions to also receive the Pension alongside the innocent who they maimed. We have also taken the difficult but necessary step in calling for her resignation. The Commissioner has to date failed to do the right thing so our pressure MUST now be exerted upon Government and the Secretary of State, the Commissioner MUST not be re-appointed for a further term of office., she cannot and will not advocate on behalf of our constituency of victims/survivors (the largest constituency)

## Esther Hurst - Health & Wellbeing Caseworker

She's very determined and doesn't turn down any opportunities. I currently work for the Western Health & Social Care Trust in Mental Health & Learning Disability in a Day Centre. I studied at Stranmillis university College Belfast after completing my A Levels. Growing up my Dad served in The Ulster Defence Regiment, The Royal Ulster Constabulary and the PSNI, he has since retired and enjoys steel work. I am looking forward to commencing my post in SEFF as Health & Wellbeing Caseworker in both Lisnaskea and Newtown Stewart. I am looking forward to the challenge and meeting you all in due course.



## Ian Irwin - Advocacy Support Worker (SEFF's new South Armagh Gateway Service)



I was born in a small, rural village in East Tyrone and brought up in an area that 'The Troubles' has had a lasting and devastating impact upon the minority community. Outside of work I am an active member of the community and strive to make a positive impact in my local area through various organisations I am a member of. I studied at Queens University and obtained a BA Hons degree in Management. I have vast experience of working with innocent victims & survivors including posts within South Armagh victims group FAIR to latterly the advocacy organisation FRPU. I have campaigned tirelessly on victims related issues including the unjust current definition of a victim. I previously worked for the Northern Ireland Prison Service and achieved promotion to a senior rank. This post deepened my understanding of trauma impact and conflict resolution. This career path has helped to aid my personal development and I am considerate of the confidentiality requirement and related sensitivities associated with my new position. I am very much looking forward to building upon my work with FRPU and using my prior involvement to help to maximise this new SEFF gateway service into South Armagh & South Down.

## Alan Lewis - Advocacy Support Worker (SEFF's new South Armagh Gateway Service)

I am a 30 year old married father of two from Clough Co Down. I formerly worked as a political aid at Stormont for five years before moving into the victims sector. The most high profile case being when I worked alongside the Kingsmill families during their inquest proceedings.

In 2012 during my role at Stormont I travelled to Brussels where I addressed a delegation of MEP's at the European Parliament on the "radicalisation of children by terrorist organisations." I was also heavily involved in the raise the Maze campaign and this trip formed part of overall efforts to prevent a terrorist shrine being put at the Maze Prison.

I was recently elected onto Newry, Mourne and Down District Council, topping the poll in the Slieve Croob area of the district.

I am very much looking forward to this new challenge, I have had a long interest in the victims sector, during my previous roles I have sought to bring victims issues to the fore. SEFF is an organisation that I am proud to be associated with, we are carrying out vital work documenting, archiving and raising victims issues while engaging with the legacy process. I would be keen to meet with innocent victims/survivors in the South Armagh and South Down areas.

This is an exciting time to be joining the SEFF team, with discussions ongoing at Stormont and the out workings of the flawed Stormont House Agreement. I look forward to playing my part, ensuring that innocent victims and survivors of terrorism are represented and the legacy of our troubled past is not rewritten or forgotten.

## SEFF's South Down Gateway Service

## **Delivery MUST now follow - IVU**

Kenny Donaldson, Spokesman for Innocent Victims United: "We are encouraged by recent comments from Nigel Dodds made in Parliament concerning the need for the Military Covenant to be applied equally across the United Kingdom and the need for a U.K. wide definition of victim of terrorism".

"Men and women from Northern Ireland have served and continue to serve the Crown and UK State within the security forces, they do so alike their counterparts across England, Scotland and Wales and just as veterans from across Great Britain have access to the rights contained within the Military Covenant, so too must N.I.-based veterans enjoy those rights - this is a matter of equality".

"There must be an end to the politicisation of our veterans and their practical needs across welfare, health and well-being, housing etc".

"Meanwhile the continuance of the 2006 definition of Victim as laid out in the Northern Ireland Order is wilful State sponsorship of a rewrite of The Past. The definition infects the environment in which victims issues operate".

"Whilst welcoming Nigel Dodds remarks, the real test will be that in the expected negotiations the DUP will have/or indeed are having with the Conservative and Unionist Party concerning an extension to the 'Demand and Supply deal' that these issues are not merely asks or appeals but rather are cast iron commitments given with timelines attached".

"Northern Ireland MUST finally be lifted up from the place it has fallen due to two plus decades of political appeasement of The Provisional Republican Movement and Terrorism across the board".

"SEFF and IVU initiated the call for a UK-wide definition of victim of terrorism to be developed and we implore Government to heed that call and set about implementing change, which would have a transformative impact upon our Society," concluded Mr Donaldson

## **Pension MUST be delivered for Innocent Victims**

SEFF statement following the Publication of The Victims Commissioner's advice to The Secretary of State on A Pension (VASPA) for the Seriously Injured.

We alike others have campaigned for many years for the provision of a special recognition payment/Pension to be made available to the seriously injured. In September last year we launched a Contract with the seriously injured in which this item was very much to the fore and we secured significant political backing for our stance.

Let's be clear; we will not be goaded into a cynical and cruel game of pitting one innocent victim off against another. We fully appreciate the financial hardship that many have experienced down the years and recognise the failings of our political system to address the issues thus far.

Those who continue to struggle and who fear for the future and who crave to have some measure of financial security should not be put in a position where they are effectively being blackmailed into offering support for a Pension which incorporates terrorists/perpetrators and for which the greater majority of innocent victims understand to be wrong.

The fact that today's proposals were launched to the Media minus consultation with the sector illustrates the lack of consent that exists for the content - and that is deeply insulting to innocent victims.

The UK Government must now make right with this issue by accepting and legislating amendments which ensure that no pension/payment can be made payable to;

1. Those who went out to harm others but were themselves injured in the consequence of their actions.
2. Those with serious Troubles related criminal convictions.

There is also an urgent need for work to be completed on other classifications of victim/survivor and the need for recognition/reparation payments to be made ie to the bereaved and those displaced from their homesteads due to violence and intimidation motivated by sectarian and ethnic hatreds.

These matters must be resolved once and for all, a UK-wide definition of victim of terrorism is the basis to unlock these issues.

# SEFF Says a Sad Farewell

## Willie Frazer 08-07-1960 to 28.06.2019

SEFF's deepest sympathies are with the Frazer family after the sad passing of Willie. First and foremost Willie was loved and cherished by his own family but many others loved him too and then there are friends and indeed those who might have been understood as opponents but who held a healthy respect for him based on his family's lived experience of sectarian and ethnic motivated terrorism - terrorism which stole 6 members of Willie's family.

Willie committed a substantive section of his life to fighting innocent victim's issues and is most closely associated with the case to secure compensation for Gadaffi's terror victims murdered by The Provisional IRA and also of pursuing fuel and diesel smugglers and criminals operating in south Armagh and our borderlands. He was also the prominent campaigner alongside the Kingsmill families consistently supporting their efforts down the years.

Willie was a unique individual, he had sharp wit and could be very charming. Yes he had flaws but so too does every one of us. We pray for Peace for the Frazer family over the coming period as they mourn and grieve the loss of Willie.



## Beatrice (Bea) Worton 22/09/1927 to 05/07/2019



Bea Worton carried her pain with immense dignity down the years, she battled long and hard for justice and she was a constant in standing up for what is right - her tenacious spirit was admired by very many people.

Her name is synonymous with the Newry Playpark issue (named after convicted terrorist Raymond McCreech) and where she took on the local Council in the Courts and what's more, defeated them.

Bea was a regular attended of the Kingsmills inquest, she craved justice and accountability for the sectarian motivated murder of her son Kenneth and nine other innocents by the Provisional IRA. Sadly she passes not having saw the end of the Inquest".

SEFF's prayers are with the Worton family as they grieve the loss of a special lady, someone who inspired and also plucked the consciences of those who should know better and who must do better.

## SEFF to run a bus to Op Banner Commemoration Event - 17<sup>th</sup> August – Wallace Park, Lisburn

The event is set to take place in Wallace Park, Lisburn, on Saturday 17<sup>th</sup> August, to commemorate the deployment of the British Army on to the streets in support of the civil power to combat the terrorist threat. The occasion will begin with a Drumhead Service at 11am, conducted by Revd's Edwin Fraser and Andrew Thompson.

After the Drumhead Service, a parade of Operation Banner veterans will make its way from Wallace Park through Lisburn to mark the occasion, passing and laying wreaths at three memorials on its way - the Lisburn Half Marathon Bomb Memorial and the UDR Memorial in Market Square and the War Memorial in Castle Gardens.

Fourteen bands are expected to participate in the parade, which will return to Wallace Park where the Wellington Silver Band will conclude the ceremony. Hot and cold beverages will be available in the park from mobile vendors, with all proceeds going to the Mayor's chosen charity - Air Ambulance NI.

Everyone is welcome, especially Veterans, families of the bereaved and injured, and all others who wish to show their support. It is expected that including participants and visitors, there will be upwards on 10,000 people taking part, this is probably a conservative estimate.

SEFF will have a gazebo set up near the bandstand, with the usual information and merchandise. As part of the commemoration event, visitors can make their way to the city centre where an Operation Banner Veteran's Museum will be set up in a marquee in Market Square. An Ulster Aviation Society Westland Scout Helicopter and old military vehicles will also be on display outside the Irish Linen Centre and Lisburn Museum. A bus will depart from SEFF at 8.30am to attend the event, pick ups can be arranged on route. The cost is £5 per person, please note there will be no meal included. 
