Dear Member,

Work continues to increase within SEFF as we push forward in our quest to best represent the innocent victims and survivors of terrorism and fother Troubles related criminal violence.

The organisation is currently recruiting across 8 new positions - 1 x Advocacy Support Manager, 4 x Advocacy Support Workers, 2 Health and Wellbeing Caseworkers (funded via Peace IV) and a Monitoring and I.T Development Officer (funded via VSP) We hope to have all new personnel in place by 1st July 2017.

Since the last Newsletter we have also been on an AfIV Project respite/good practice visit to Edinburgh which was well received by those attending. Importantly SEFF was able to outreach to GB -based victims/survivors with a number of families joining with SEFF's N.I-based members for the first time.

I want to also recognise those Clergy who came together to work collaboratively with SEFF in offering a victim-centred service of Prayer and Reflection on the day in which Martin McGuinness was buried. This was entirely the right thing to do and the large numbers attending (despite the short notice) bears this out.

The death of Martin McGuinness brought a wide spectrum of response. On a human level SEFF takes no glee on the death of anyone irrespective of what they may or may not have done within their life on this earth. We acknowledge that Martin McGuinness will be grieved by his own family and others.

However it must be said that upon news breaking this morning Martin McGuinness death that many innocent victims of and survivors IRA terrorism have been expressing feelings of being further cheated - cheated of the prospect of obtaining some form accountability through information Mr McGuinness could have chosen to provide to them but instead has taken to the grave with him.

Martin McGuinness will now meet his Maker and unlike on this earth, he won't be able to dodge accountability citing the IRA's Green book or any other document. Each and every one of us faces the same destiny.

I also want to take this opportunity to thank all staff and volunteers within SEFF who have pulled together in recent weeks in ensuring that the work of closing down one financial year and opening another is being completed without detriment to those who we are in place to serve.

We wish to also remind members and others that SEFF offices will be closed for May Day Bank Holiday on Monday 1st May and also Monday 29th May. The office will reopen again on the Tuesday's of each respective week @ 9am.

### **SEFF visit Scottish Parliament**

Over the course of the weekend 24th - 27th March, over 40 members of South East Fermanagh Foundation visited Edinburgh for a good practice visit which included a tour within the Scottish Parliament and a Presentation-based meeting with Tom Arthur MSP for Renfrewshire South (Parliamentary Liaison Officer to the Cabinet Secretary for Justice)

Our Director of Services Kenny Donaldson stated: "Over the weekend we brought together well over 40 innocent victims and survivors of terrorism who came from all parts of the United Kingdom and the Republic of Ireland, Protestant and Roman Catholic, Unionist and Nationalist - their common bond was and is **'innocence**.'

"Within our Presentation to Tom Arthur we raised the following issues, the plight of War Widows who remarried and had their pensions removed from them, the case of the Three Scottish Soldiers including recent comments made by Scottish National Party's John Mason and services for victims and survivors living in Scotland and the need for pro-activity by the Scottish Government".

"We found Mr Arthur to be empathetic and engaging with our group which included a number of Scottish families. He unreservedly apologised to our group for the harm caused by Mr Mason when he recently described the IRA's campaign of violence as being that of 'freedom fighters.' He confirmed the comments to be 'disgusting and wrong.'

"Mr Arthur (**pictured below**) who had spoken to colleagues within the SNP and across the other political parties in advance of meeting with SEFF committed to taking for a range of action points including; increasing pursuing the potential for a Reception event to be held in parliament for SEFF and Scottish-based families of terrorism, to redouble efforts in lobbying for the MOD to reinstate a Pension for War Widows who remarried and to re-examine ways in which the Scottish and N.I devolved administrations could share information ensuring that a joined up approach is taken in supporting the needs of victims and survivors of terrorism. Critically he also committed to speaking to colleagues around how the Scottish Government could do more in standing by and with the families of The Three Scottish soldiers and others impacted by Northern Ireland-related terrorism".

Other visits completed over the weekend included The Royal Yacht Britannia, Edinburgh Castle etc.

### **A Night In Memory Of Kirsty Clarke**

On Monday 20th March 2017 SEFF held a night in memory of Kirsty Clarke. The event took place in Lisnaskea High School, where Kirsty had spent part of her secondary education before it closed it's doors in 2013. There was a huge attendance which showed Kirsty's family & friends the high esteem in which she was held across the locality and indeed beyond.

On the evening we had a presentation from Irwyn McKibbin of Heartbeat NI (who also presented a defibrillator to the Clarke family for Aghavea Church of Ireland Parish which the family belong to)

Hymns were played by Lisbellaw Accordion Band (which Kirsty and her sister Zara were members of). The band members spoke fondly of Kirsty & shared some special memories.

A short film had been put together by SEFF in collaboration with Lyons Digital Productions, the film illustrated Kirsty's life and contribution within

various SEFF projects including pics and footage of Kirsty being interviewed plus family-based presentation of photographs involving Kirsty from birth ..

An Irish Stew supper was served.

Kenny Donaldson, our Director of Services stated: "Kirsty was and will continue to be a shining beacon of hope for so many others. She came from a family who have demonstrated insurmountable levels of courage and restraint over many, many years".

"Kirsty lived life and she lived it well, she is an example to all of us not to quit, to fight on and to always




be the best we can be. SEFF was extremely proud to hold this event in conjunction with the Clarke family".

### ACT APRIL 2017 UPDATE

The Spring FACT newsletter has been sent out thanks to our hard-working bunch of volunteers. Our spring newsletter contains a wide range of activities in varied locations to encourage people to get out, learn something new and socialise.

Intergenerational work is an integral part of The FACT Project.

Good relations between generations fosters respect both ways and has been proven as a factor in reducing anti-social behaviour. We are delighted to have received funding from Linking Generations NI under their AllAgesApril to facilitate such a project.

Pupils at Ballinamallard PS are acting as iPad "Buddys" to enable FACT & Grandparents members to learn how to use iPads for everyday activities such as shopping, reading a book or looking up bus timetables. Facetime and messaging demonstrate the ease of keeping in touch with family members both near and far. This was of huge interest to the FACT participants many of whom had family abroad.

Ballinamallard PS pupils also demonstrated how school lessons on reading, writing and arithmetic are now carried out in school using iPads, breaking down the perceptions that iPads are just for fun.

Together they created an interactive eBook of the project which included audio files comparing the older and younger participants experiences of a "typical day at school".

The FACT Project have also received funding from Community Pharmacy Programme and will be hosting an event in Lisbellaw in association with Lisbellaw Medical Hall. This will cover medication and herbal alternatives, good sleep, minor ailments and will also feature a session by Cruse Bereavement making salt memory jars.

More and more studies are indicating that it's good to eat foods which aren't processed and are prepared at home with fresh ingredients. FACT, SWAP and Colebrook Kitchen Garden are offering this opportunity in 2017. We will deliver an ongoing course where participants grow the ingredients to cook

wholesome nutritional meals. This is ideal for those who don't cook, don't garden or don't do either! Session 1 has been completed and participants picked rhubarb before preparing

together a delicious but healthy rhubarb crumble. Its not too late to join in.

### Research Update

The research and admin assistant, Matthew, will no longer be engaged in Advocacy

work. I would like to thank him for his assistance and support over the last 18 months, and his valuable contribution in his role. I will be combining any future research work with my advocacy role.

### Casework Update

- AfIV are now engaging with almost 60 families, some cases more complex than others.
- The same issues continue with the PSNI and other governmental organisations, and that has not alleviated. I do not expect that to change, and quite simply we must remain resilient in our role.
- All Rol agencies, government, Garda and Garda Ombudsman (GSOC) are particularly problematic; we will continue to pursue them in order to gain some measure of success.
- A number of current cases are being assisted by legal firms and we await any possible updates. This will be time consuming and do not expect anything in the near future.
- We continue to build a data base of HET reports that may be revisited when

- the new SHA structures are in place.
- Following the recent application process to VSS, SEFF were successful in funding through PEACE IV for an Advocacy team of one manager and four case workers. This provides a level of resilience within the increasing workload giving a much greater chance of success in legacy cases, and augers well for the future.

The AfIV respite weekend trip took place in Edinburgh during the dates 24<sup>th</sup>-27<sup>th</sup> March inclusive, and was deemed a very rewarding and enjoyable weekend.



### Legacy and the PSNI
