Dear Member,

Slowly but surely life is returning - not fully as before but nevertheless people are beginning to once again come together with family members and close friends and connections, the need for human support is now starting to be possible again.

Yet the truth is that we are still in a very fragile position as a Nation with a real and present risk being that the pandemic could re-emerge through a second phase.

If this were to happen it may be that particular sub-areas of our Nation would experience a form of lockdown/restrictive living as opposed to the entire Nation - but we cannot be certain of these issues.

At SEFF we have been trying our best to prepare ourselves for the new circumstances facing us, we have incorporated Perspex screen protection within the SEFF offices, pump hand sanitizers exist outside all offices, masks and gloves are also available and rooms have been re-calibrated to permit limited gatherings of people.

Over the period of COVID-19 SEFF was the only victim/survivor support group across Northern Ireland to have it's core office staffed, we did so because we acknowledged that the constituency we are privileged to support are vulnerable, we were cognisant that the lock-down would bring forth many issues of emotional, psychological, financial and other practical nature.

In having our Lisnaskea office manned members were assured that when ringing that familiar number: 028 677 23884 that they would get a familiar voice on the other end of the phone.

Over these months SEFF staff, supported by our incredible volunteers have worked hard to try to offer support that would meet the evolving and changed needs of our members and we hope that the interventions we introduced were helpful and that you felt supported and connected to us ie grocery drops, energy top-ups, computers for families struggling with I.T needs, an enhanced telephone support service, telephone based counselling, welfare advice, health and wellbeing, advocacy etc.

At this point in time we are conscious that there is a balance which must be struck between absolutely observing the medical advices which are in place and which serve to guard the population from COVID and also the need to engage and support people so that issues connected with emotional and mental health and wellbeing (which have become even more pronounced over this period) are able to be addressed.

We also acknowledge that many people have been extremely lonely over this period of time, due to not being able to see family and friends, attend Church, come to SEFF group activities or the raft of other interests they may enjoy but we have also heard of some incredibly uplifting stories of members who have learnt new skills over the period or who have re-ignited an interest from bygone years - there have also been blessings over this difficult period.

Over the coming 6 weeks we hope to welcome our new Office Manager to SEFF - Emma Burton, say a prayer that she is able to secure a flight to return to Fermanagh from Australia.

I would also like to take the opportunity to welcome Anna Waterworth to the Staff Team who has been appointed Clinical Coordinator p/time. Anna started at the beginning of June and will be based from Rathfriland. And we also welcome new Counsellors to SEFF's team; Gary Powell and Briege Reynolds who each come with substantive experience.

I would also like to place on record SEFF's Management's thanks to the core team of staff who worked within the SEFF Lisnaskea office, (supported by volunteers) over the last four months and outreach staff who diligently continued to offer support to SEFF members and others connected to our partner groups.

**In now addressing SEFF's release from lock-down, we anticipate the following phased approach (dates are indicative and are subject to change)**

**Step 1.**

All N.I SEFF Staff back to work and operating from SEFF offices

Timeline: Everyone now back.

**Step 2.**

Return of 1-1 support services within SEFF offices by prior appointment.

Services which this relates to are: Welfare, Health and Wellbeing Caseworker's Service, Advocacy.

Appointments will be facilitated in a larger room with social distancing measures and other protections in place.

Timeline: From Wednesday 1st July 2020 onwards.

Indicatively, home-based appointments will not be facilitated at this point unless it is impossible for the member to come to a SEFF office. In such circumstances a meeting may be facilitated if there is a suitable outdoor area attached to the property. Such requests will be dealt with as compassionately as is possible. We would hope that home-based appointments may be able to return by mid-August/September 2020.

**Step 2 Contd.**

Return of Physiotherapy (Nicola McCullagh-Daley and Foot care/Foot therapy via Ruth Watson

We project that Massage, Aromatherapy and Reflexology therapies may return by mid-August 2020.

Expressions of interest for all therapies can be made now by contacting the SEFF office on: 028 677 23884 with immediate referral possible for the services provided by Nicola and Ruth.

**Step 3.**

Piloting some smaller group-based work ie luncheon dinners, some courses such as chair aerobics for smaller numbers of participants, re-establishing the walking group etc.

Return of home-based befriending support.

Timeline: Mid-August/September 2020

**Step 4:**

Larger group meetings ie monthly member meetings, Church services, courses and seminars with larger attendances, respite etc.

Timeline: October 2020

The same arrangements exist across our offices in Bessbrook, Rathfriland and Newtownstewart

### Sgt Patrick Morrissey - 27th June 1985

Sgt Patrick Morrissey was murdered 35 years ago today by Provisional IRA terrorists.

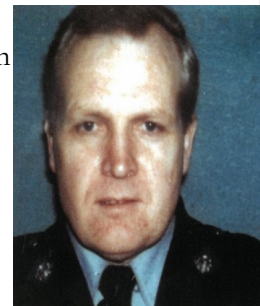
Sgt Morrissey was born on 7th March, 1936, he originally came from Belturbet, Co. Cavan. He joined An Garda Síochána on 14th December 1960 but prior to that served in the National Army from 1953 to 1960. After almost 14 years' service Patrick was promoted to Sergeant on 24th October 1974. Sergeant Morrissey served in various locations including Waterford, Drogheda, Dublin, Omeath and Collon, County Louth.

Patrick was an experienced life-saver, his allocation to Headquarters saw him play a major role in the development of the Garda Sub-Aqua Unit. He was married with four children. Sergeant Morrissey was posthumously awarded the Scott Gold Medal on 4th December 1986.

On 27th June 1985, Gardai Peter Long and Brendan Flynn were on mobile patrol at Ardee, Co. Louth. As they approached the town's Labour Exchange they came upon a robbery in progress. Two armed men had ambushed the manager and stolen £25,000 in cash. When the raiders saw the patrol car they fled the scene in the manager's car, discharging their firearms at the two Gardai.

Following in pursuit, the patrol car picked up Sergeant Morrissey along the way. The chase ended abruptly at Rathbrist Cross, when the raiders, now on a motor-cycle, crashed into an approaching car, injuring the occupants of the car. Gardai Flynn and Long stayed with the injured persons while Sergeant Morrissey, alone and on foot, pursued the raiders. As he caught up with them a shot was fired and he fell to the ground grievously wounded. One of the gunmen stood over him and at point blank range shot the Sergeant dead.

The Scott Medal was posthumously awarded to Sergeant Patrick Morrissey on 4th December 1986. In 2013 he was also awarded the Freedom of Drogheda by Drogheda Borough Council, it was the first such award of its kind.



### Support for the Bereaved

Over the past several years SEFF has been campaigning on behalf of Bereaved victims/survivors, calling for effective and just acknowledgement. We are aware of how shamefully the bereaved were treated (particularly in the 1970's and 1980's) where pitiful levels of compensation were offered or given to those whom had the most stolen away from them. We continue to campaign for an effective remedy to this, that the bereaved would receive a form of acknowledgement pension or payment which would act as a reparation.

We are calling upon families within our membership (and others known to you) to advise us if you are not in receipt of these support payments. It would mean; £1,000 of support for someone who has had a spouse/partner murdered/killed, or £500 of support for someone who has had a parent or child murdered or killed as a result of 'The Troubles' - and there are no geographical or time-based restrictions.

Please contact the SEFF office on: 028 677 23884 and advise us if your family or you as an individual meet this criteria and are not currently registered with the VSS and receiving this annual financial payment.

Please be advised that siblings of those murdered/killed are not eligible for the Bereaved payment although we continue to lobby for a redress of this issue.



### **William (Robert) Gilliland - 18<sup>th</sup> June 1985**

SEFF remembers Robert Gilliland on this the 35<sup>th</sup> Anniversary since he was murdered. Robert was murdered via a Provisional IRA landmine explosion taking place on 18<sup>th</sup> June 1985.

Constable Gilliland died while undergoing emergency surgery after he was caught in the IRA explosion near Kinawley. His colleague (Jeff Smith) was also seriously and permanently injured having to be cut free from the vehicle.

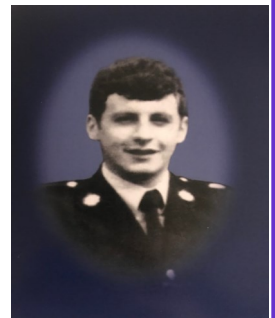
Robert was from Lisbellaw. He was married with two children. He joined the RUC Reserve in 1972 and became full time in 1975. He was 39 years old when he was murdered.

Robert is remembered by widow Connie, their two boys Simon and Keith and the extended family

### **Garda Officer Henry Byrne and Detective Garda Officer John Morley - 7<sup>th</sup> July 1980**

Garda Officer Henry Byrne and Detective Garda Officer John Morley are remembered 40 years after they were murdered by INLA terrorists.

On the afternoon of 7<sup>th</sup> July 1980 the Bank of Ireland, Ballaghaderreen, Co. Roscommon was robbed of £41,000 by two armed and masked men. Having made their escape the raiders, (three of them in all), burned their getaway car and transferred to another a short distance away and headed towards Castlerea.



Garda Henry Byrne with colleagues Sergeant Michael O'Malley, D/Garda John Morley and Garda Derek O'Kelly intercepted the raiders at Aghaderry, Shannon's Cross, some five miles from Ballaghaderreen, where the raiders' vehicle collided with the patrol car. One of the raiders shot at the windscreen of the patrol car. The other two raiders then opened fire on the patrol car killing Garda Byrne. Having pursued the raiders Detective Garda Morley was shot dead a short distance away.

Henry Gerard Byrne was born on 24th March, 1951, came from Wingfield, Knock, Claremorris, Co. Mayo. He joined An Garda Síochána on 8th March, 1972. He served at Mullingar, Multyfarnham, Granard and Carlow. At the point of being murdered Henry was aged 29 years, a married man with three children, Paul (5), Henry (4) and Aisling (who was born 4 months after his murder).

Henry was posthumously awarded the Scott Gold Medal on 16th September, 1982.

Henry's hobbies included cards, he also played Gaelic football at local level for Kiltimagh GAA. Henry is fondly and lovingly remembered by his family, colleagues and friends alike.



Meanwhile Detective Garda John Morley was born on 6th October, 1942, came from Faughill, Kiltimagh, Co. Mayo. He joined An Garda Síochána on 31st March, 1964. On 27th May, 1979, he was appointed to Detective Branch, based at Castlerea Garda Station. He previously served at Ballaghaderreen.

John had an interest in all types of sports but in particular Gaelic football. He played Senior Intercounty Gaelic football for Mayo for 13 seasons, winning Connacht Senior Championship medals in 1967 (as Captain) and 1969 and a National Football League title in 1970. He also played Rugby and Badminton.

John was aged 37 years old at the point he was murdered and married with three children, Detective Garda Morley was posthumously awarded the Scott Gold Medal on 16th September, 1982.

As we approach the 40th anniversary of John's death, he is fondly and lovingly remembered by his wife, children and grandchildren, colleagues and friends alike.

I then went into private practice. In 2010, I was invited to teach on the UU Foundation Degree in Counselling at SWC Omagh which I still continue to do, one day a week.

## **The Victims Pension - We MUST stand firm**

Lord Peter Hain recently stated within an article carried in the Irish Times:

"In 2006 when I was secretary of state for Northern Ireland I set out the statutory framework for the commission for victims and survivors.

The definition in the 2006 order was intentionally inclusive because I wanted to ensure that all victims and their families could get access to services like those provided today by the victims and survivors service and the new mental trauma service when it comes into operation.

But what has become known as the victims' pension is not a service.

It is the recognition and acknowledgement of the great harm done to people through no fault of their own".

### **SEFF's response**

Kenny Donaldson, Spokesman for Innocent Victims United stated: "Lord Hain is anxious to retrospectively justify the decision his Government took back in 2006 around the N.I Order".

"We have always accepted that terrorists/other perpetrators of Troubles related crime and their families may well have psychological, emotional and other needs but NEVER should this grouping of people been provided with UK State cover that they could be supported as "victims".

"Conferences and other functions have been held over the years where widows of innocent victims were in the same room as perpetrators/people who had actually committed murder - that was the impact of the Blair Government's "inclusive" definition".

"A further impact has been the appointment of those guilty of serious 'Troubles related' crimes being able to sit on a Victims Forum - forcing others to then have to leave and the largest majority of victims/survivors of terrorism not wishing to sit on that Forum because it is not simply a forum for victims".

"This is explained away as being "inclusive" but it's the polar opposite - innocent victims in their thousands are forced to self-exclude from sitting on such a Forum because they will not forsake The Truth".

"Imagine a situation where victims of domestic violence, of burglary, of rape or any other heinous crime were expected and/or forced to be spoken of in the same breath as the perpetrators of those crimes, that resources intended for their support were also provided to perpetrators and where those individuals were being asked to consider those who committed the harm also being viewed as victims".

"Peter Hain and other political leaders of that time need to show humility and understand that the 2006 Victim and Survivor Order was a very wrong road to travel. The Order has been manipulated and misused by those empowered to exploit it - enough is enough, there must be a re-calibration of our Society".

"It needs understood and acknowledged that in the context of The Northern Ireland Troubles and irrespective of grievances held whether real or perceived that there was never justification for the use of criminal violence in the furtherance of or defence of a political objective".

"The Pension for the seriously injured MUST be delivered NOW for the innocents who adhered to the law, who did not injure themselves by their own hand, who did not join illegal terrorist organisations, in-so-doing committing crime or who as members of the security forces did not dishonour the code and engage in criminal-based activities".
