SEFF Community Allotments

Over recent months SEFF have acquired resources to carry out a significant amount of work to the Allotments site based on the Brookeborough road.

Substantive drainage and remedial works have taken place making the site a sustainable resource for the medium-longer term.

Over the coming weeks a further eight plots will be developed as well as the positioning of a mobile unit complete with toilet facility which will ensure that the site's accessibility is further improved for allotment holders and others who will be able to avail of the space and natural environment offered.

We hope to have a special launch of the upgraded site in late June 2021, further details to follow.

In advance of this SEFF Management wishes to thank the team of Volunteers (predominantly Army veterans) who have worked so hard in preparing the site, supported by Contractor Rodney Noble.

<u>Shawcross Evidence Session - </u> <u>Shocking and bordering on the Farcical</u>

The Northern Ireland Affairs Select Committee session which involved evidence given by William Shawcross was shocking and borderline farcical.

It is nothing short of scandalous that William Shawcross was actively dissuaded from meeting with victims groups who support the innocents of Qadhafi-sponsored Provisional IRA Terrorism yet it was viewed appropriate that he meet with the political wing of The Provisional IRA - Sinn Fein who have many senior representatives who were active leaded within its' terror campaign and may even have been directly involved in the deals with the Libyan administration around the securing of semtex and other killing material.

Who advised Mr Shawcross not to speak to victims or the core groups who have supported them for two decades and more in pursuing these issues? It is nothing short of patronising that the reason given for non-engagement was that "expectations would be raised".

Mr Shawcross doesn't know the cultural environment we operate within very well, victims and survivors have come to realise nothing scertain, they are far from naïve.

We requested an engagement session with Mr Shawcross which was not facilitated and nor were we reached out to by him despite the fact that we are the largest consortia of organisations supporting the innocents of terrorism. We should never have been in a position to beg him for a meeting, the process should have demanded that he speak to us, that respect be given of our credibility and the constituency of people whom we support.

This is a common thread of Government, the Criminal Justice system and indeed our Churches, little proactive engagement happens from their part, we almost always have to initiate contact and that situation is deplorable, it illustrates arrogance, lack of respect and predetermined agendas - victims marginalised is the culture - not victim centred.

The language chosen by Mr Shawcross and related throughout the hearing would indicate that his brief was to 'hush up' this issue from the perspective of the U.K. Government. Increasingly it looks probably that this is down to two core reasons - the U.K. State's economic and security interests but also its' cowardice around the potential unearthing of material which could be embarrassing and damaging to the leadership of Provisional Sinn Fein.

Once again innocent victims/survivors of terrorism are being used as cannon fodder. We will regroup along with others and will determine next step options open to us - there are legal issues to explore concerning the interest accumulated on frozen Libyan assets and decisions taken by Government around the expending of these monies.

Furthermore, the UK Government holds the key to unlock the process through the use of its' veto on The UN Security Council, no Libyan frozen assets should be released until there is an agreement around the compensating of those impacted by their former leaders International campaign of terror, exercised in the UK by his sub-contractors, The Provisional IRA.

The U.K. Government needs to realise something once and for all - the victims haven't gone away you know. Your prevaricating has meant many have gone to their graves never seeing accountability served in these issues but there remains victims and their representatives who will continue to insist that you do the right thing, and that you are to sacrifice justice, truth and accountability in an effort to continue a fraudulent appeasement process of terrorism.

The UK State is fast becoming a cold house for innocent victims/survivors of terrorism; public policy is not led by the overarching need for justice to prevail, those who have laid down their lives for the State have been treated shamefully and, in many ways, the terrorism inflicted upon them continues to be inflicted through a State that is unwilling to stand by and for the rights of innocents.

Since that session, IVU then gave Evidence to the Select committee.

We asserted that a secret deal was done by the then Blair Government in an effort to close off this issue.

The reasons: Political, Economic and also related to the Peace Process. We will continue to press for accountability of this issue, there is no rationale of any substance that can be put forward by the UK Government for not using income stream coming from tax revenues on frozen Libyan assets held in London, the government has no excuse for further delay in starting a compensation process.

Any monies used now in advance of a final deal with Libya should be recovered later. For a deal to be done, London must be prepared to use its veto at the UN Security Council and prevent a release of frozen assets unless an accommodation can be reached.

<u>Developments welcomed on TPDPS (AKA Victims Pension Scheme)</u> but case will continue for the Bereaved - SEFF

Kenny Donaldson, SEFF's Director of Services stated: "We welcome recent confirmation contained in correspondence sent by The Executive Office to the High Court that Stormont Ministers are undertaking to work on behalf of their respective departments in ensuring that payments will be made to successful applicants".

"The key part within the correspondence was the acknowledgement that "the payment is an entitlement as indicated by the court, and regardless of whether it comes from Westminster or from our block grant, it will be paid when it is due".

"This will be met positively by many victims and survivors impacted by permanent disablement brought about through their exposure to terrorism and other Troubles related events".

"It is important that the Scheme opens as soon as there is a robust process in place for managing applications submitted. We reiterate our position which is long held, that terrorists or other perpetrators of criminal based actions must not be recipients of this Scheme, if that were to happen then it would compromise the Scheme's integrity".

Mr Donaldson added: "We also continue to assert the need for an appropriate reparations scheme to be developed acknowledging the bereaved of 'The Troubles.' The level of compensation (or in some cases non compensation paid) at the time of brutal murders was derisory and shameful - that wrong must be put right, and we will continue to campaign intensively in this regard".

"The Republic of Ireland State must also get its' act finally together and introduce comparable provision for Irish citizens living in its' jurisdiction who were impacted by 'Troubles related events' within the Republic, it is unacceptable that such individuals should be retreated differently - there must be equality of treatment for all those impacted, irrespective of where they happen to live," concluded Mr Donaldson.

Next steps:

SEFF continues to sit on the Sectoral Implementation Group concerning the development of the TPDPS, we are represented via Norman Kirkpatrick (Welfare/Appeals Officer) and Dr Philip McGarry (Chairman of SEFF's H +WB oversight committee) offers support in our interactions with the President of the Board; Justice Gerry McAlinden.

It is anticipated that the Scheme will open in July/Augusts 2021 SEFF has recruited additional Welfare officers who will be available to guide those wishing to apply through the process. They will be honest and transparent and will advise if they feel you would not meet the eligibility criteria for the Scheme.

We will be in touch over the coming weeks with details of further steps and in the May Newsletter we will be featuring the new staff appointed to help support you through the process.
